




DESIGN CRITERIA

<u>cULus Listing Requirements:</u> Microfast® and MicrofastHP® EC/QREC Horizontal Sidewall Sprinklers VK609 and HP VK613 are cULus Listed as indicated in the Approval Chart for installation in accordance with the latest edition of NFPA 13 for extended coverage sidewall spray sprinklers:

- · Sprinkler VK613 is limited to Light Hazard occupancies with smooth, flat, horizontal ceilings only.
- Sprinkler VK609 is cULus Listed for Light Hazard occupancies with smooth, flat, horizontal ceilings. Sprinkler VK609 is also listed for ceilings with slopes to 4/12 (18.4°), as a QREC "Specific Application Sprinkler".
- For sprinkler VK609 in sloped ceiling applications, Sections 11.2.3.2.3 and 11.2.3.2.4 of the 2007 Edition of NFPA-13 do not apply regarding System Area of Operation. Sprinkler VK609 should be installed according to the areas of coverage, and flows and pressures listed in the Approval Chart on page 91j.
- In sloped ceiling installations, sprinkler VK609 is listed for installation at the high-point intersection of the wall and the ceiling. In sloped ceiling installations, the spray must be directed down the slope. Spray may NOT be directed across the slope. Refer to Figure 6.
- Listed area of coverage for sloped ceilings corresponds to ceiling slope. (For sloped ceiling applications, actual floor coverage will be less than the listed area.)
- Refer to the Approval Chart for required deflector distance below the ceiling. Install with the leading edge of the deflector oriented parallel to the ceiling (see Figure 6).
- Minimum distance from end walls is 4 in. (102 mm).
- Maximum distance from the end wall shall be no more than one-half of the allowable distance between sprinklers. The distance shall be measured
 perpendicular to the wall.
- The sprinkler installation and obstruction rules contained in NFPA 13 for extended coverage sidewall spray sprinklers must be followed.

Viking sprinklers are to be installed in accordance with the latest edition of Viking technical data, the appropriate standards of NFPA, FM Global, LPCB, APSAD, VdS or other similar organizations, and also with the provisions of governmental codes, ordinances, and standards, whenever applicable.






